

# WEBSITE PRIVACY POLICY

i-VisioNET, Inc. is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the i-VisioNET, Inc. Web site and governs data collection and usage. By using the i-VisioNET, Inc. website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

i-VisioNET, Inc. collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. i-VisioNET, Inc. also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by i-VisioNET, Inc.. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by i-VisioNET, Inc. for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the i-VisioNET, Inc. Web site.

## **Use of your Personal Information**

i-VisioNET, Inc. collects and uses your personal information to operate the i-VisioNET, Inc. Web site and deliver the services you have requested. i-VisioNET, Inc. also uses your personally identifiable information to inform you of other products or services available from i-VisioNET, Inc. and its affiliates. i-VisioNET, Inc. may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

All such third parties are prohibited from using your personal information except to provide these services to i-VisioNET, Inc., and they are required to maintain the confidentiality of your information.

i-VisioNET, Inc. does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

i-VisioNET, Inc. keeps track of the Web sites and pages our customers visit within i-VisioNET, Inc., in order to determine what i-VisioNET, Inc. services are the most popular. This data is used to deliver customized content and advertising within i-VisioNET, Inc. to customers whose behavior indicates that they are interested in a particular subject area.

### **Use of Cookies** *ComponentOne C1Pdf (Evaluation Version)*

The i-VisioNET, Inc. Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
